7. ITEMS FROM THE FLOOR

In response to an inquiry from Mrs. Judy Johnson regarding the Valencia High School girls' locker room modernization project, Mr. Mike Bailey discussed the design process and options.

Mr. Bailey and Mr. Mike Chafin discussed the approach being taken for this summer's modernization projects. Construction schedules will extend into next school year and into the following summer for Rio Vista Elementary School and Kraemer Middle School. Modest interim housing will be provided at all sites to accommodate the construction schedule; however, testing schedules will not be disturbed.

In response to an inquiry from Mrs. Judy Johnson, Mr. Verdugo indicated that Educational Services is reviewing the summer school schedule to minimize the impact on staff and students affected by modernization.

In response to a question from Mr. Tom Lindsey regarding the North Orange County Community College (NOCCC) campus, Mr. Verdugo indicated the North Orange County Community College District operates the Forum Theater with the balance of the buildings being the responsibility of the PYLUSD which maintains a number of programs at that site. Mrs. Rosemary Gladden shared that district programs at the site included Adult Education, Child Care, and Music.

Mr. Warren Hennagin asked about the progress at Bernardo Yorba Middle School. Mr. Gary Boyer replied that Building 300 is currently undergoing modernization and that the administration building is also slated for renovation.

Mr. Mike Kairis discussed the status of the Valencia High School project in response to an inquiry from Mr. Art Moncrief. In addition, Mr. Moncrief shared that his conversations with teachers reflect that most are pleased with the results of modernization projects at their respective school sites.

Mr. Verdugo indicated that meetings are ongoing with school staffs on what to anticipate during modernization projects.

The next meeting is scheduled for Wednesday, September 22, 2004, 6:00 p.m., at the District Education Center, located at 1301 East Orangethorpe Avenue, Placentia, California, in the Superintendent's Meeting Room.
